Subject: Budget Appropriation of Funds Request

BACKGROUND:

In August 2019, the District applied for an Assistance to Firefighters Grant to purchase two LUCAS Chest compression devices to deliver cardiopulmonary respirations. Unfortunately, due in part to the District's success in securing prior Federal Grants, the District was not awarded this AFG grant.

RECITALS:

The LUCAS chest compression system has a solid base in CPR science and has been evaluated for safety and efficacy in clinical and experimental studies since its launch in 2003. The LUCAS device has shown to increase hands-on times and blood flow to the heart and brain.

CONCLUSION:

Overall, revenue and expenditures are as planned and budgeted. In addition, the District is continuously looking to secure other financial resources and continues to remain financially prudent and good stewards of public funding.

It is staff recommendation that the Board of Directors approves the allocation of \$38,000.00 from the unassigned fund balance to the Medical Supplies program funding for the purchase of two LUCAS Chest compression devices. Contra Costa County Employees Retirement Association;

At its October 14, 2020 meeting, the Retirement Board reviewed the actuary's valuation report for the year ending December 31, 2019, and adopted the recommended employer and employee contribution rates, which will become effective on July 1, 2021. A copy of the December 31, 2019, Actuarial Valuation can be found on CCCERA's website at www.cccera.org under the Actuarial Valuations link.

Reporting: Chief Craig

Labor Relations – Personnel - All COVID-19 safety precautions remain in place. Crew safety and protection remain our most significant concern. Crews are strictly following CDC, County Health, and the Medical Directors' guidelines on personal protective equipment, EMS responses, and decontamination. Personnel currently monitor their health before, when arriving, and during their duty shift. Personal protective equipment supplies and burn rates are monitored and tracked by the department's medical program manager. Crews have now been supplied with washable gowns to try and extend our gown supplies. The District is currently following recommended CDC guidelines in response to employee illness and or exposure to COVID-19. The District now has four employees out on worker's compensation leave, none related to COVID-19. The District presented a conditional offer for a Paramedic position. That conditional offer was accepted, and the individual is currently in a background investigation.

Fire Stations/Training Facility— District offices are now open with specific requirements for all public entering the building. Group training is still suspended, along with public education functions. Telephone calls to the business line have now been routed to Administrative Services Officer Kim Corcoran's cell phone anytime the front office is not staffed. A Measure "O," Senior Exemption Form drop box was installed at the front door of the administrative offices. This drop box is to add convenience for after hour drop off and to assist with social distancing.

Probationary employees are continuing their training and Task Book signoffs.

Reporting: Chief Craig

Facilities – Phase 1 of 4 of the concrete removal and replacement project for Station 76 is complete with the removal and replacement of the driveway. The next phase (Phase 2) will be the resurfacing, expansion, and ADA code adjustments of the parking lot will begin shortly. A Modular Building contractor was hired to complete repairs on the foundation of the classroom.

Grants/Reimbursements – The District is currently submitting Grants to several grant funding opportunities; a more detailed description will be provided at the November Board meeting. The District has submitted its application to FEMA and received authorization to begin the process for submitting for

federal reimbursements. **Reporting:** Chief Craig

Incident Activity – Response activity has returned to normal to an above-average call volume. This trend will continue as new development begins to populate. See the attached fire response report for September.

Community Risk Reduction – Company conducted business inspections are currently on hold and will resume in January. The District's website and new Facebook page will continue to be populated with relevant information about the Fire District and current events.

Community /Wildfire Prevention –. Fuel reduction and creation of defensible space in the wildland-urban interface areas is complete. Distribution of weed abatement notices to the public as well as all homeowner associations is also completed. Members of the public and Homeowner association that requested in-person inspections of their property are completed. Staff will continue working with homeowners, city officials, homeowner associations, to address wildfire prevention and wildfire risk management.

Fleet Management – The ladder Truck is on schedule for delivery in early December, and the Type 1 Engine is now scheduled for April 2021.

Fiscal Stabilization – The first-quarter financial report will be delivered at the November Board meeting. Staff is training on the new Purchase request software program to replace its current outdated system.

Measure O Oversight Committee Staff Report

Meeting Dates:

The Measure O Oversight Committee last convened for a full meeting on September 16, 2020 via Zoom. The prior Measure O Oversight Committee meeting was on June 17, 2020, also via Zoom.

Attendance:

In attendance were the 4 Committee members: Paul Freese, Annie Ziff, Marie Bowman and Elizabeth Genai. Committee member Genai attended her first Measure O Oversight Committee meeting in September. Fire Chief Bryan Craig recorded booth meetings and insured that the agenda and documents were available to Committee members and public, both online from the RHFD website or upon request at Station 76. There were no public attendees at either the June or September meeting.

Committee Actions:

At the June 17, 2020 Measure O Oversight Committee meeting (attended by Paul Freese, Annie Ziff and Marie Bowman), after reviewing the Auditors Report and the Fire Chief Report on Measure O funds and expenses for Fiscal Year 2018-19, the Committee approved the final Measure O Oversight Committee Report for FY18-19 to be delivered on time to the RHFD Board of Directors at their July meeting. Special thanks to Committee member Marie Bowman for doing the bulk of the writing and editing on the Measure O report. Due to an administrative oversight, the final Measure O report was never delivered to the Board at the July meeting. This went unnoticed by the Measure O Committee until the agenda for the September meeting was posted. During the September meeting, the Committee asked the Fire Chief to deliver the already approved final Measure O Oversight Committee Report for FY18-19 to the Board at their October meeting with explanation as to why the delay occurred.

Activities:

The main activities the Committee engaged in during the September meeting are as follows:

- 1. The agenda item "Confirming the Agenda" led to an extensive discussion resulting in the Committee action and request mentioned above.
- 2. The prior meeting minutes were not in the documents packet for review, so the Committee tabled approving the minutes until the next meeting.
- 3. The Committee discussed "Public Outreach" and determined that due to the County and Health Services lockdown for Covid-19, outreach will be discontinued until after the shutdown has been lifted. The Committee noted that "outreach" included both seeking Measure O Oversight Committee members and also educating the public on the Committee's purpose and activities. Use of "NextDoor" was mentioned as another vehicle for outreach. (Note: we are still seeking a 5th member)
- 4. The next Measure O Oversight Committee meeting was scheduled for Wednesday, February 17, 2020 at which time the Committee will begin work on review of Measure O funds for fiscal year 2019-20 and restart public outreach activities.



MEASURE O OVERSIGHT COMMITTEE REPORT

FISCAL YEAR 2018-2019

History

Measure O, a special tax replacement measure was approved by the voters on November 8, 2016, to be used for any lawful purpose permissible to Fire Districts pursuant to California Health and Safety Code Section 13800 et seq., including but not limited to enhancing the level of fire protection, emergency fire protection and paramedic response services through increasing staffing levels to operate and maintain the District's fire stations, maintaining and when necessary replacing fire protection and lifesaving equipment and apparatus to optimal levels of function, and to fund capital improvements.

Purpose

To independently review the expenditures of the Measure O parcel tax revenues for compliance with the special tax and to inform the public and advise the Board if the funds were expended in accordance with the intentions of the voters.

Financial Highlights

Measure O funding replaced the expiring Federal SAFER grant, allowing the District to continue to employ firefighters hired with grant funds while keeping both fire stations open and fully staffed. These funds were used for Permanent Salaries and the CCCERA Unfunded Actuarial Liability Payments. 345 Senior Exemptions, (Residents 65 and older residing in the exempt property), an increase of 114 exemptions from Fiscal Year 2017-2018 were received, amounting to a reduction in funding of \$74,520. Beginning in the 2020/21 budget cycle a separate budget category will be created within the budget narrative detailing the revenue and expenditures of Measure O.

Financial Summary

Measure O Revenues received were \$2,405,916, and total expenditures were \$2,332,606, leaving a fund balance of \$217,401.

Measure O funds were used to reimburse the following General Fund Expenses:

Permanent Salaries July 2018 through December 2018: \$1,200,312

Unfunded Actuarial Accrued Liability November 2018 through June 2019: \$1,122,560

Detailed Measure O expenditure information is provided in the Independent Accountant's Report; see Exhibit A.

Conclusion

The Measure O Oversight Committee has determined that Measure O parcel tax revenues for Fiscal Year 2018-2019 were expended in Fiscal Year 2018-19 in accordance with the voter-approved requirements of Measure O. Additionally the unexpended amount of \$217,401 was carried forward for expenditure in Fiscal Year 2019-2020.

We have performed the procedures enumerated below, which were agreed to by the Rodeo - Hercules Fire Protection District' management, on the Rodeo - Hercules Fire Protection District's (the "District") Measure O - Special Tax revenues received and expenditures made by the District for the fiscal year ended June 30, 2019. The District's management is responsible for the receipt of Measure O - Special Tax revenues and deposit of such proceeds into the District's Measure O - Special Tax Revenue Fund and use it solely for any lawful purpose permissible to the District as instructed in Ordinance 2016-1. The sufficiency of these procedures is solely the responsibility of the District's management. Consequently, we make no representation regarding the sufficiency of the procedures enumerated below either for the purpose for which this report has been requested or for any other purpose.

PROCEDURES:

The procedures performed and findings are listed below:

1. We agreed the actual Measure O - Special Tax proceeds collected and expended to the amounts recorded in the District's general ledger and recalculated the mathematical accuracy of the following schedule provided by the District:

County Collection Fees - Contra Costa County assesses fees to levy assessments and taxes. Charges for the Measure O Levy totaled \$9,734, which was paid using Measure O Fund resources.

2. We traced the proceeds of the Measure O tax and reviewed the expenditures made by using those proceeds, as listed in aforementioned schedules, in accordance with Ordinance 2016-1 Section 4 and California Health and Safety Code section 13800 et seq regarding use of tax proceeds.

FINDINGS:

Proceeds of taxes as listed in the schedule presented by the District's management were paid into the District's Measure O Special Revenue Fund and had been used by the District, in compliance with Ordinance 2016-1 Section 4 and California Health and Safety Code section 13800 et seq, with no exceptions.

This engagement to apply agreed-upon procedures was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants. The Fire Chief, or his designee, including but not limited to the District's chief fiscal officer, shall file an annual report with the Board. The annual report shall at a minimum, report upon the following: (a) The amount of tax proceeds collected and expended; and (b) The status of any project required or authorized to be funded in accordance with

this section.

History

In November 2016, the residents of Rodeo and Hercules voted overwhelmingly to pass Measure O, an annual parcel tax of \$216.00 (this amount may increase annually by the lesser of 3% or the CPI in the San Francisco-Oakland-San Jose Area by a vote of the Board of Directors). This funding replaced the expiring Federal SAFER Grant, allowing the District to continue to employ firefighters hired with grant funds, and keep both fire stations opened and fully staffed.

Senior Exemptions

Seniors who are 65 or older are eligible for an exemption to the parcel Tax. Seniors must reside in the property for which they are claiming an exemption, and they must fill out an exemption form on an annual basis, and turn it into the Parcel Tax Administrator by the deadline of January 31 of each year. All complete and eligible exemptions that were received by January 31 were submitted to the County for exclusion on the tax roll.

The proceeds of the special tax funding replacement measure imposed by this Ordinance shall be placed in a special account or fund to be used solely for any lawful purpose permissible to Fire Districts pursuant to California Health and Safety Code §13800 et seg., including but not limited to enhancing the level of fire prevention, emergency fire protection and paramedic response services through increasing staffing levels to operate and maintain the District's fire stations, maintaining and when necessary replacing fire protection and lifesaving equipment and apparatus to optimal levels of function and performance, and to fund capital improvements.

Measure O Revenues received were \$2,405,916, and total expenditures were \$2,332,606, leaving a fund balance of \$217,401.
