RE: City of Hercules New Development

BACKGROUND:

During the regular February board meeting, the board requested staff to provide an update on planned development within the Hercules city limits. This is a discussion item.

INFORMATION:

1. Bayfront / Waterfront Development:

- Opened in 2020, "The Exchange" features 172 Apartment Units located at 2300 John Muir Parkway.
- Opening in 2021, "The Grand" features 246 Apartment Units located at 1200 John Muir Parkway.
- Block P features 498 Apartment Units located on John Muir Parkway will begin construction in 2021.

These multi-storied mid-rise apartment buildings will also have a commercial component featuring retail sales and restaurants.

2. Hilltown:

• Located at the intersection of San Pablo and Highway 4, Hilltown will feature 600 Multi-Family Townhomes and 4,200 square feet of commercial space. Groundbreaking for this project is scheduled for Spring 2021.

3. Franklin Canyon Golf Course:

• Located on Highway 4, the golf course is converting 9 of the 18 holes of the existing Golf Course to 160 Recreational Vehicle Spaces and constructing a 17,000 Square foot clubhouse and waterpark.

4. Sycamore Crossing:

• Located at the intersection of Sycamore Avenue and San Pablo Ave, Sycamore Crossing will feature 120 Multi-Family Townhomes, a 105 room Hampton Inn Hotel and 30,000 Square Feet of Commercial space. Grading and underground for this project are currently underway.

5. Safeway:

• Safeway grocery store featuring a Starbucks Coffee and a Fueling Station will open April 1, 2021. A separate commercial structure located on the Safeway site houses a Peets Coffee and Chase Bank.

6. Willow Self Storage:

• A two-story Multi-unit self-storage facility with housing for the property manager on site. The site will also feature a Carwash and Auto Service Center.

Several other projects are awaiting approval from the planning commission; "The Bowl," a Townhome project that will feature the Hercules historical clubhouse, a powder plant office building at its gateway, and a single-family home development at the end of Skelly drive.
